Tallahassee USBC Association's End of the Year Tournament

- This tournament is open to all Tallahassee USBC members who have local association membership as of
 February 1, 2016. The tournament will consist of two divisions (Handicap Singles & Scratch Singles). Bowlers
 must choose the division they will participate in. They <u>cannot</u> bowl in both. The following rules and current
 USBC rules will govern this tournament.
- 2. Bowlers will bowl 3 qualifying games in their selected division (Scratch or Handicap), on one pair of lanes.
- The tournament will be held at Crenshaw Lanes 104 CRB Oglesby Union, Florida State University,
 Tallahassee, FL 32312 on SATURDAY- JUNE 4, 2016 beginning at 11 AM.
- 4. There will be one shift, with the possibility of a second (dependent on number of entries) for the tournament. On-site registration will be between 9:30 AM and 10:45 PM and must be paid by cash or money order. Pre-registration entries should be mailed to the Association Manager, Lisa Tajdari, 2430 Buttonbush Court, Tallahassee, FL 32308. Checks, payable to Tallahassee USBC Association, must be received by May 27, 2015. No cash via the mail.
- 5. Tournament fees will be \$20.00 per entry (\$10.00 bowling and \$10.00 prize fund).
- 6. The top 5 bowlers in each division will participate in a step ladder roll-off following the qualifying shift(s). Bowlers 4 & 5 in each division will compete for the right to compete against Bowler 3 in their division, and so on. Roll-offs are 1 game events with the highest score in each division advancing. Ties will result in a two-frame roll-off.
- 7. Bowlers will use their highest 2015-2016 USBC average (21 games or more) as of April 1, 2016 as their entering averages. Bowlers with only sport averages will use their sport average adjusted to a regular average (per USBC Standards). Bowlers with sport averages higher than regular averages will use their sport averages unadjusted. Bowlers without any of the above averages will bowl scratch.
- 8. Handicap will be 90 percent of the difference between the bowler's entering average and 220.
- 9. USBC Rules 319a-3 (bowler responsibility for reporting and verifying average) will apply. We will have the latest league sheets available. Some leagues may already be completed.
- 10. USBC Rule 319c (Tournament Manager's authority to rerate bowlers prior to competition), USBC Rules 319d (reporting of tournament winnings over \$600) and USBC Rule 319a-2, the 10-pin rule, is waived.
- 11. Scores from the computer printouts and scoring monitors will be the official score.
- 12. The Tournament Manager reserves the right to decide all questions and disputes arising in this tournament.

 The decisions will be final, subject to appeal to USBC.
- 13. All protests must be made in writing to the Tournament Manager and within the time limits specified by USBC (See USBC Rule 329).
- 14. A prize ratio of 1 to 6 or portion thereof will be used. The Prize Fund will be returned 100 percent. Payment will be sent out following average verification. The Tournament has 30 days to disperse the prize fund.
