Annual Breast Cancer Singles Bowling Tournament

1. **All USBC tournament rules will apply**
2. This tournament is open to all adult entrants who wish to bowl. It is a handicap/scratch singles tournament to raise funds for Breast Cancer. Prize fund will be returned 100 percent. **All bracket profits and expense funds will be donated by TUSBCA to the Tallahassee Memorial Hospital for Cancer Patients through USBC's Bowl for the Cure Program. 3. The tournament will be held at **Capital Lanes, 820 Capital Circle NE., Tallahassee, Florida**. Bowlers may bowl on any or all available shifts. There will be two shifts on Saturday, October 25, 2014 with a starting time of 12:00 pm and the next one at 3:00 pm. **On-site registration will begin one hour prior to shift times and must be paid by cash or money order. Registration closes 30 minutes prior to shift time.** Pre-registration entries can be mailed to the Tallahassee USBC Association, 2430 Buttonbush Court, Tallahassee, FL 32308. Checks can be used as long as entry is received by October 22, 2014. Checks should be made out to Tallahassee USBC Association. **Do not send cash in the mail.**
4. Pre-registration Tournament fees will be \$25.00 per entry (\$10.00 bowling, \$3.00 expense fee and \$12.00 prize fund). Day of the tournament entry fees are \$30.00 per entry (\$10.00 bowling, \$8.00 expense, \$12.00 prize fund). Cash or money order only accepted on day of tournament.
5. **A scratch option will be offered for \$10.00 with distribution of \$8.00 Prize Fund and \$2.00 Expense Fee**, if entries permit.
6. Each bowler will roll a 3-game series on one pair of lanes. **Multiple entries are allowed. However, a bowler cannot place more than once on the prize list for position standing in each prize category (handicap and scratch).**
7. All bowlers that don't have a 2014-2015 USBC membership card will be required to obtain membership onsite or be charged a participation fee. Participation fee is \$5.00. Payment of the fee prior to participation entitles the entrant to participate in this tournament only and subjects the bowler to the USBC rules and jurisdiction for this tournament. Participants who pay the participation fee are not eligible for USBC awards. Bowlers obtaining full USBC membership (\$18.00) will be eligible for all USBC awards.
8. Bowlers will use their highest 2013-2014 USBC yearbook average (21 games or more) as entering averages (any association). Bowlers with only sport averages will use their sport average adjusted to a regular average. Bowlers with sport averages higher than regular averages will use their sport averages unadjusted. Bowlers without a 2013-2014 yearbook average will use their highest 2012-2013 average. Those without either may use their highest 2013-2014 average with 21 games or more as of January 1, 2014. Bowlers using 2014-2015 averages are requested to bring average verification from their association manager. All other bowlers will bowl scratch. (Including participant bowlers)
9. **USBC Rule 319a-2, commonly referred to as the 10-pin rule will be in effect. Please know your current average as of the last date you bowled if your current average is ten pins or more above last year's average.**
10. USBC Rules 319a-3 (bowler responsibility for reporting and verifying average) and 319c (Tournament Manager authority to rerate bowlers prior to competition) will apply.
11. USBC Rules 319d (reporting of tournament winnings over \$600) and 319e (reporting of tournament averages 15 pins above entering averages) are waived.
12. The computer printouts and monitor scores will be the official score.
13. The Tournament Manager reserves the right to decide all questions and disputes arising in this tournament. The decisions will be final, subject to appeal to USBC.
14. All protests must be made in writing to the Tournament Manager and within the time limits specified by USBC (See USBC Rule 329).
15. A prize ratio of 1 to 6 or major portion thereof will be used. The Prize Fund will be on a handicap basis and will be returned 100 percent. Handicap will be 90 percent of the difference between the bowler's entering average and 220. Payment will be sent out following average verification and may take 3-4 weeks.

Help us raise funds for Bowl for the Cure. Leagues will be asked to solicit donations through their league the week prior to the tournament and will have any funds designated as their league's contribution.
